**A RESOLUTION** awarding a twenty-four (24) month term and supply contract, and approving one twelve-month option for extension, on Electronic Solicitation No. BB200627 for the furnishing of ready mix concrete and flowable fill for use by the Parks and Recreation and Public Works Departments to Penny's Concrete, Inc., of Shawnee Mission, KS, to provide for departmental needs.

WHEREAS, the Director of Finance and Purchasing has solicited bids on Electronic Solicitation No. BB200627 for the furnishing of Ready Mix concrete and Flowable Fill for use by the Parks and Recreation and Public Works Departments to provide for departmental needs for the upcoming twenty-four month period with an annual option to extend for a term not to exceed an additional twelve months; and,
