WHEREAS, the Family Court Division has been awarded a grant in the amount of \$213,997.00 for a Mentoring Program by the U.S. Department of Health and Human Services, for the period of September 30, 2010, through September 29, 2011; and,

WHEREAS, the grant funds will be used to implement and develop a adult and youth communitybased mentoring program for children at risk; and,

WHEREAS, the requires a local match in the amount of \$53,499.00; and,
