## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing an increase and Addendum to Agreement for the furnishing of transitional living expenses for homeless persons to Newhouse of Kansas City, MO, at an increased cost in the amount of \$3,008.00 to the County for a total cost to the County not to exceed \$18,008.00.

WHEREAS, by Resolution 14866, dated January 12, 2004, the Legislature did authorize the County Executive to execute Agreements with certain organizations which provide assistance to homeless persons, at an aggregate cost to the County not to exceed \$718,555.00; and,

WHEREAS, Newhouse of Kansas City, MO, is an authorized provider of assistance to homeless persons by Resolution 14866; and.

WHEREAS, an increase of \$3,008.00 to the previously approved amount of \$15,000.00 for Newhouse of Kansas City, MO, by Resolution 14866 is recommended by the Housing Resources Commission to cover additional expenses and services, for a total amount not to exceed \$18,008.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive
