IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the County Executive to execute agreements with certain outside agencies which engage in anti-drug and anti-violent crime related activities, to provide a local match to federal, state, local, and/or private grant funds, at an aggregate cost to the County not to exceed \$14,000.00.

WHEREAS, by Resolution 19397, dated February 27, 2017, the Legislature did authorize the execution of agreements with certain outside agencies engaged in anti-drug and anti-violent crime law enforcement, treatment, and prevention activities requiring a local match to grant funds; and,

WHEREAS, additional grant match funds have been identified, and the Jackson County Drug Commission now recommends that the County Executive be authorized to execute agreements with the following outside agencies in the amounts indicated, for grant match funding:

Kansas City Crime Commission	\$12,500.00
Palestine Senior Citizen Activity Center	\$1,500.00

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be, and hereby is, authorized to execute agreements with these outside agencies in the respective amounts indicated, in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be, and hereby is, authorized to make all payments, including final payment on the agreements.
