AN ORDINANCE appropriating \$25,000.00 from the fund balance of the 2008 Grant Fund to cover a grant received from the Missouri Highway and Transportation Commission in acceptance of the Jackson County Sheriff's Office Safe Routes to School Program grant, and authorizing the County Executive to execute a Program Agreement regarding said grant.

WHEREAS, the Missouri Highway and Transportation Commission has awarded the Sheriff's Office a grant in the amount of \$25,000.00 to cover the Safe Routes to School Program, which will provide safer biking and walking accommodations for children in grades K-8; and,
