WHEREAS, on January 26, 2016, the Sixteenth Circuit Court of Jackson County announced the appointment of a new Public Administrator, John P. Killian, to serve for a four-year term; and,

WHEREAS, in conjunction with this appointment, the Probate Division of the Circuit Court has ordered a final settlement of the accounts under the former Public Administrator's control; and,

WHEREAS, the Public Administrator recommends a Consulting Agreement with Rebbecca Lake Wood, the outgoing Public Administrator, to provide assistance in compliance with this order; and,

WHEREAS, a transfer is necessary to place the funds needed for this Agreement in the appropriate spending account; and,
