IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$100,000.00 from the unappropriated surplus of the 2006 Special Road & Bridge Fund and authorizing the County Executive to execute a Cooperative Agreement with the City of Kansas City, MO, for a study of the Lee's Summit Road Corridor, at a cost to the County not to exceed \$100,000.00.

ORDINANCE # 3805, September 11, 2006

INTRODUCED BY Bob Spence, County Legislator

WHEREAS, the Director of Public Works recommends a Cooperative Agreement with the City of Kansas City, MO, for a twelve-month study of the Lee's Summit Road Corridor; and,

WHEREAS, the City of Lee's Summit has provided the County with funds to reimburse the County for expenses the County advanced on the Woods Chapel Road Project which were a Lee's Summit obligation; and,

WHEREAS, the Director of Public Works proposes to use a portion of this City of Lee's Summit reimbursement to pay the costs of the Lee's Summit Road corridor study; and,

WHEREAS, an appropriation is necessary to place these funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the unappropriated surplus of the 2006 Special Road & Bridge Fund be and hereby is made:
