A RESOLUTION authorizing the County Executive to execute an agreement with Cypress Research Associates of Kansas City, MO, to provide an evaluation of the Prosecuting Attorney's Office's Drug Court's Mental Health Toughness Group, at a cost to the County not to exceed \$5,000.00.

WHEREAS, the Prosecuting Attorney's Office's Drug Court's Mental Toughness Group is a program which encourages successful completion of drug court requirements through team building and counseling; and,

WHEREAS, the Prosecuting Attorney's Office desires to retain Cypress Research Associates of Kansas City (Jackson County), MO, to evaluate the process and measured outcomes of the Mental Toughness Group program, at a cost to the County not to exceed \$5,000.00; and,

WHEREAS, this agreement is in the best interest of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute a contract with Cypress Research Associates, for the evaluation, in a form to be approved by the County Counselor, at a cost to the County not to exceed

\$5,000.00; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
