A RESOLUTION awarding a twelve-month term and supply contract on Electronic Solicitation to Bid No. BB200442 for the furnishing of imprinted promotional items for use countywide to BPA Printing & Promotions of Lenexa, KS (\$29,904.81), Hasty Awards of Ottawa, KS (\$4,899.92), Teamco International of Buffalo Grove, IL (\$745.00), and Proforma Webster & Associates of Fort Worth, TX (\$9,523.00) in the estimated aggregate amount of \$45,072.73.
