A RESOLUTION awarding a term and supply contract on Bid No. 103-98 for the furnishing of petroleum products for use by the Public Works and Parks and Recreation Departments to Heathwood Oil Co. of Kansas City, KS (\$6,008.70), Gard Corporation of Kansas City, KS (\$5,986.00), and Universal Lubricants, Inc. of Wichita, KS (\$8,953.55), to provide for their needs for the upcoming one-year period, in the estimated aggregate amount of \$20,948.25.

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 103-98 for the furnishing of petroleum products for use by the Public Works and Parks and Recreation Departments; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in awards to the following vendors:

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget...Attorney
