A RESOLUTION transferring \$162,000.00 within the 2008 General Fund to cover the costs of miscellaneous repairs and improvements to various County buildings.

RESOLUTION #16732, October 6, 2008

INTRODUCED BY Bob Spence, County Legislator

WHEREAS, the downtown courthouse is in need of various repairs, including security improvements to the garage area, assistance in the movement of several departments, and repairs to the elevators, and the Criminal Justice Building and Independence Courthouse Annex require the replacement of failing air conditioners; and,

WHEREAS, a transfer is necessary to cover these costs; and,

WHEREAS, the County Executive recommends this transfer; now therefore,
