**A RESOLUTION** transferring \$40,448.00 within the 2010 Anti-Drug Sales Tax Fund to cover funding for the Sheriff's Office's 2010 Drug Abuse Resistance Education (DARE) program.

WHEREAS, by Resolution 17273, dated May 5, 2010, the Legislature did authorize the allocation of one-half of the budgeted Anti-Drug Sales Tax funds for the Sheriff's Office's 2010 Drug Abuse Resistance Education (DARE) program, and;

WHEREAS, the COMBAT Administration now recommends that the remaining balance of \$40,448.00 in the Sheriff's Office's Anti-Drug Sales Tax Fund be transferred to its 2010 DARE program; and,

WHEREAS, the County Executive has recommended said transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made within the 2010 Anti-Drug Sales Tax Fund:
