AN ORDINANCE appropriating \$26,489.27 from the fund balance of the 2010 General Fund to cover the costs of additional postage expenses in the Circuit Court during the 2009 fiscal year.

ORDINANCE #4189, February 1, 2010

INTRODUCED BY Scott Burnett, County Legislator

WHEREAS, by Resolution 15672, dated October 24, 2005, the County awarded a twelve-month term and supply contract for the furnishing of outgoing mail services for use by the Finance and Purchasing Department to Mail Solutions, Inc., of North Kansas City, MO, under the terms and conditions of Invitation to Bid No. 20-04, through an existing government contract; and,

WHEREAS, by Resolution 16071, dated November 13, 2006, the County did enter into three twelvemonth extensions of the contract, commencing November 30, 2006, under the terms and conditions of Bid No. 20-04; and,

WHEREAS, the County was notified that Mail Solutions, Inc., went out of business in November 2009, after the County already submitted pre-payment for the balance of the year; and,

WHEREAS, the County Counselor's Office immediately filed suit to recover the funds prepaid to Mail Solutions, Inc.; and,
