A RESOLUTION awarding a term and supply contract on Bid No. 109-97 for the furnishing of recreational wearing apparel for use by the Department of Corrections to Raytown Screenprint of Kansas City, MO (\$6,135.00), Midwest Sales of Kansas City, KS (\$1,257.07), and Jerry's Sport Shop of Grandview, MO (\$738.50), to provide for departmental needs for the upcoming one-year period, in the estimated aggregate amount of \$8,130.57.

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 109-97 for the furnishing of recreational wearing apparel for use by the Department of Corrections; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in estimated awards to the respective vendors as follows:

Midwest Sales Kansas City, KS	\$1,257.07
Jerry's Sport Shop Grandview, MO	\$738.50

therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agency have heretofore been made in the current Jackson County budget...Attorney
