A RESOLUTION awarding a term-and-supply contract on Bid No. 34-04 for the furnishing of landscaping supplies for use by the Parks and Recreation and Public Works Departments to Keller's Flowerhouse & Landscaping, Inc., of Independence, MO (\$39,000.00), Grass Pad, Inc. of Olathe, KS (\$35,000.00), and BWI Companies of Lenexa, KS (\$6,000.00), to provide for departmental needs for the upcoming one-year period, in the estimated amount of \$80,000.00.
