A RESOLUTION awarding a term and supply contract on Electronic Solicitation No. BB200395 for the furnishing of chemicals and fertilizers for use by the Parks and Recreation Department to Floratine Midwest of Raymore, MO (\$8,450.00), Helena Chemical of Lenexa, KS (\$31,990.00), Lesco, Inc., of Strongsville, OH (\$18,000.00), Outdoor Equipment/US Turf of Grandview, MO (\$6,800.00), and Grass Pad, Inc., of Olathe, KS (\$23,250.00) to provide for departmental needs for the upcoming one-year period, in the estimated aggregate amount of \$88,490.00.
