### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$55,760.00 from the fund balance of the 2008 General Fund and \$9,160.00 from the fund balance of the 2008 Assessment Fund to cover the increased costs for employee parking.

WHEREAS, due to an unanticipated increase in parking costs, there are inadequate funds to cover employee parking expenses and an additional \$64,920.00 is required to finish the year; and,
