### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing the County Executive to execute a First Addendum to the contract with County Court Services, Inc., of Kansas City, MO for the furnishing of drug treatment services for use by the Jackson County Drug Court, in the estimated amount of \$600,000.00 and extending the term for a period of 12 months.

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, by Resolution 13428, dated November 13, 2000, the Legislature authorized a contract with County Court Services, Inc., of Kansas City, MO, for the furnishing of drug treatment services for use by the Jackson County Drug Court; and,

WHEREAS, the Prosecuting Attorney has recommended an increase to this contract in the amount of \$600,000.00, and that the term of this Agreement be extended through September 30, 2002, in order to allow County Court Services to continue providing treatment/counseling services to participants of the Jackson County Drug Court program; and,

WHEREAS, the attached First Addendum to Agreement provides a suitable mechanism by which to implement the Prosecuting Attorney's recommendation in this regard; therefore,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments on the Agreement, as amended.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
