### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing the payment of \$156,119.83 to the City of Blue Springs, Missouri, from the City of Blue Springs CURS account to assist the City with the cost of improvements to Woods Chapel Road.

**INTRODUCED BY** Bob Spence, County Legislator

WHEREAS, pursuant to section 2836., Jackson County Code, 1984, the City of Blue Springs, MO, has requested the use of its County Urban Road System (CURS) funds in the amount of \$156,119.83 to cover the cost of improvements to Woods Chapel Road; and,

WHEREAS, this project is a part of the CURS system; and,

WHEREAS, the Director of Public Works recommends approval of the request; and,

WHEREAS, the Legislature finds that the Woods Chapel Road improvements by the City will benefit the citizens of Blue Springs and the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that, pursuant to chapter 28, Jackson County Code, 1984, the Director of Finance and Purchasing is authorized to issue a check in the amount of \$156,119.83 as a lump-sum payment to the City of Blue Springs for use by

the City on improvements to Woods Chapel Road.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
