IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a one-year term and supply contract for the furnishing of outboard motor repair parts and accessories for use by the Parks and Recreation Department to Bombardier Motor Corporation of America of Waukegan, IL, in the estimated amount of \$18,000.00, as a sole source purchase.

RESOLUTION # 13914, December 3, 2001

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends the award of a term and supply contract, for the furnishing of outboard motor parts and accessories for use by the Parks and Recreation Department to Bombardier Motor Corporation of America of Waukegan, IL; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that is the only known supplier providing parts and accessories for its own proprietary outboard motors; therefore,

BE IT FURTHER RESOLVED that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County a contract with Bombardier Motor Corporation of America of Waukegan, IL; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent that sufficient appropriations to the using spending agency are contained in the current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
