WHEREAS, the Missouri Department of Elementary and Secondary Education has awarded a grant to the Family Court Division of the Circuit Court for its National School Lunch Program, Juvenile Detention Food Service Program, for July 23, 2009, through October 23, 2009; and,

WHEREAS, this program is used for replacement of kitchen equipment in the Juvenile Detention Kitchen, which provides meals for detained adolescents; and,

WHEREAS, an appropriation is necessary in order to place the grant funds in the proper spending accounts; now therefore.
