A **RESOLUTION** awarding a term and supply contract on Bid No. 42-00 for the furnishing of mattresses, bedding, and linens for use by the Department of Corrections to Bob Barker Co., Inc. of Fuquay, NC (\$14,700.00), Chestnut Ridge Foam of Latrobe, PA (\$2,700.00), Harbor Linen of Cherry Hill, NJ (\$11,300.00), Tabb Textile Co, Inc., of Opelika, AL (\$4,500.00), ICS of Waco, TX (\$5,000.00), and Signature Textiles of Atlanta, GA (\$350.00), to provide for departmental needs for the upcoming one-year period, in the estimated aggregate amount of \$38,550.00.
