AN ORDINANCE appropriating \$3,000.00 from the unappropriated surplus of the 2007 Grant Fund to cover the Family Court Division's Guardian Ad Litem training grant, received from the Office of State Courts Administrator.

WHEREAS, an appropriation is necessary to place the grant funding in the proper spending accounts; now therefore,
