IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION approving a contract for the purchase of one 1996 Ford Ranger long wheelbase compact pickup in the amount of \$11,930.00 from Shawnee Mission Ford of Shawnee, KS, and three 1996 Ford Crown Victoria full size 4-door sedans with police package in the amount of \$54,771.00 from Broadway Ford of Kansas City, MO, for use by the Public Works Department, under an existing government contract of the Mid-America Council of Public Purchasing, in the actual aggregate amount of \$66,701.00.

INTRODUCED BY John C. Graham, County Legislator

WHEREAS, the Director of Purchasing pursuant to Section 1040.05 of the Jackson County Code, 1984, recommends the purchase of one 1996 Ford Ranger long wheelbase compact pickup in the amount of \$11,930.00, from Shawnee Mission Ford of Shawnee, KS, and three 1996 Ford Crown Victoria full size 4-door sedans with police package in the amount of \$54,771.00 from Broadway Ford of Kansas City, MO, for use by the Public Works Department, under Joint Governmental Fleet Bid, an existing government contract of the Mid-America Council of Public Purchasing; and,

WHEREAS, Section 1064.00, Jackson County Code, 1984, requires that, for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the purchase under the existing government contract be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
