A RESOLUTION approving the purchase of sixteen (16) full-size 4-door sedans with police package and four (4) mid-size 4-door sedans for use by the Sheriff's Department, from Joe Machens Ford of Columbia, MO, in the actual amount of \$395,464.00, under an existing State of Missouri government contract.

RESOLUTION 13587, February 26, 2001

INTRODUCED BY Terry Young, County Legislator

WHEREAS, the Director of Purchasing pursuant to Section 1040.04 of the <u>Jackson County Code</u>, 1984, recommends the purchase of sixteen (16) full-size 4-door sedans with police package and four (4) mid-size 4-door sedans for use by the Sheriff's Department, from Joe Machens Ford of Columbia, MO, in the actual amount of \$395,464.00, under an existing State of Missouri government contract; and,

WHEREAS, Section 1064.00, <u>Jackson County Code</u>, 1984, requires that, for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the purchase under the existing government contract be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
