WHEREAS, the Boys & Girls Club of Greater Kansas City is the surviving entity resulting from a merger of the Boys and Girls Club of Greater Kansas City and the Boys & Girls Club of Eastern Jackson County and the surviving entity has a West Side Unit and an East Side Unit to serve County residents; and,

WHEREAS, in accordance with prior requests \$25,000.00 for the funding of the former entity, Boys and Girls Club of Eastern Jackson County, was appropriated in the 2005 budget, but since no proposal was ever received from that former entity, no agreement was ever executed; and,

WHEREAS, the County and Boys & Girls Clubs of Greater Kansas City-East Side Unit, as the successor to that former entity, has submitted a proposal to enter into an Agreement whereunder the County will contract for services for the previously appropriated amount of \$25,000.00 with Boys & Girls Clubs of Greater Kansas City-East Side Unit for the Project Learn program which will focus on
