## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** transferring \$31,079.62 within the 2008 Road and Bridge Fund to cover the emergency repair of a natural gas line for use by the Sheriff's Office.

**INTRODUCED BY** Bob Spence, County Legislator

WHEREAS, pursuant to section 1030.3 of the <u>Jackson County Code</u>, 1984, the County Executive has declared an emergency to authorize the repair of a gas leak at the Sheriff's Office headquarters; and,

WHEREAS, U.S. Engineering was called to repair the gas leak in order to prevent additional problems, under an existing contract with the County to perform services on call; and,

WHEREAS, in order to fund this repair, a transfer is necessary; and,

WHEREAS, the use of the contingency fund is appropriate for this transfer due the unforeseen nature of the emergency; and,

WHEREAS, the County Executive recommends said transfer; now therefore,
