File #: 12489, Version: 0 IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI A RESOLUTION authorizing the County Executive to execute an agreement with Boys and Girls Club of Eastern Jackson County, with a local match from the County not to exceed \$15,000.00. RESOLUTION #12489, December 15,1998 INTRODUCED BY Dennis Waits, County Legislator WHEREAS, Boys and Girls Club of Eastern Jackson County has been awarded a grant from the National Boys and Girls Clubs of America through the Bureau of Justice, in the amount of \$15,000.00, to be used in connection with its "Teen Center"; and, WHEREAS, this pilot program is designed for youth in the Eastern Jackson County area, ages 13-18, who are from disadvantaged circumstances; and, WHEREAS, Boys and Girls Club of Eastern Jackson County has requested County Anti-Drug Sales Tax matching funds in the amount of \$15,000.00; and, WHEREAS, this is the first year for this grant program; and, WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure of these funds; therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to enter into an agreement, a copy of which is attached and incorporated herein by reference, with Boys and Girls Club of Eastern Jackson County for its Teen Center program; and, BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement. Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
