IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE renewing a conditional use permit (CUP) in District GB (General Business) for a period of twenty-five years to operate three satellite dish earth stations, as to a 10.00± acre tract.

ORDINANCE NO. 5759, June 15, 2023

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. A conditional use permit is hereby renewed for a period of twenty-five years to operate a three satellite dish earth stations, as to an approximate 10.00± acre tract of land in District GB (General Business), commonly known as 2100 Stark Avenue in Jackson County, Missouri, legally described as follows:

Description: The East 10 acres of the South 20 acres of the East Half of the Northeast Quarter of Section 7, Township 49, Range 32, in Jackson County, Missouri, except that part in Route 78 (23rd Street) and except that part conveyed to by Warranty Deed I-0327005 in Book I-838 at Page 966 in the Office of the Recorder of Deeds of Jackson County, Missouri.

<u>Section 2</u>. The conditional use permit renewed by this Ordinance is subject to the following conditions:

 The number of earth stations and supporting equipment allowed on the premises is limited to three.
