IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$135,085.00 from the unappropriated surplus of the 1995 General Fund to cover the cost of 300 voting machines for the Jackson County Election Board and to restore budget cuts for 1995 for the Kansas City Election Board.

ORDINANCE #2430, July 17, 1995

INTRODUCED BY John Patrick Burnett, County Legislator

WHEREAS, the Kansas City and Jackson County Election Boards have requested that they be allowed to utilize funds previously appropriated to them which were returned to the County unspent from the 1994 primary and general elections; and

WHEREAS, the Kansas City Board proposes to use its share of these funds to restore funds cut from its 1995 budget request and the Jackson County Board proposes to use its share of the funds to purchase 300 new voting machines; now therefore

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the appropriated surplus of the 1995 General Fund:
