A RESOLUTION awarding a contract for the furnishing of various telephone sets for use by the County Executive's Office and the Department of Corrections to Sprint of Jefferson City, MO, under a State of Missouri government contract, at the actual cost to the County of \$9,215.27. RESOLUTION # 11554, December 16, 1996

INTRODUCED BY Dixie M. Flynn, County Legislator

WHEREAS, the County desires to purchase various telephone sets for use by the County Executive's Office and the Department of Corrections; and,

WHEREAS, the Director of Purchasing pursuant to Section 1040.05 of the Jackson County Code, 1984, recommends the purchase of various telephone sets from Sprint of Jefferson City, MO, under an existing state of Missouri government contract; and,

WHEREAS, Section 1064.00, Jackson County Code, 1984 requires, that for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the purchase under the existing government contract be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payments on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
