## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing the County Executive to execute a Cooperative Agreement for Medical Examiner Services in 2010 with Platte County, Missouri, for compensation payable to Jackson County in the amount of \$75,081.00.

WHEREAS, Platte County, Missouri, a county of the first class, is required by § 58.700 and § 58.705, RSMo, to appoint a physician duly licensed by the Missouri State Board of Healing Arts as Platte County's medical examiner; and,

WHEREAS, § 58.765, RSMo, authorizes any two or more counties to, by contract, join in the appointment of a county medical examiner to serve all such counties and requires the counties' governing bodies to approve the contract, administer the appointment, and allocate the costs among the counties; and,

WHEREAS, Mary H. Dudley, M.D., the duly appointed Chief Medical Examiner of Jackson County, is fully qualified, ready, and willing to serve as Platte County's Medical Examiner as well; and,

WHEREAS, the Jackson County Medical Examiner, Jackson County administration, and Platte

County have agreed on an equitable arrangement for the funding of a joint medical examiner's office
