WHEREAS, the Board of Police Commissioners of Kansas City, Missouri has received the 2012

Byrne Justice Assistance Grant (JAG) from the U.S. Department of Justice in the amount of

\$578,423.00, for the Greater Kansas City Crime Prevention Initiative, of which \$208,000.00 has been

allocated to Jackson County; and,

WHEREAS, the grant proceeds will be used to fund provide salary and benefits for the Jackson County Drug Court and the salary for a Crime Initiative Manager; and,

WHEREAS, the grant requires no match and if for the period of October 1, 2011, through September 30, 2015; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; and,
