IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a term and supply contract on Bid No. 119- 95 for the furnishing of miscellaneous PC hardware and software for use county-wide to Midwest Typewriter of Kansas City, MO, Cedar Computer of Overland Parks, KS, Egghead Software of Liberty Lake, WA, Business World of Fremont, CA, Sidus Computer of Larkspur, CA, M & M Automated of Amherst, NJ, D & H Distributing of Harrisburg, PA, KJM Marketing of Sioux City, IA, Matrix Data of Cleveland, OH, Win Labs of Monmouth Junction, NJ, America Direct of Lenexa, KS, Computer Cable of Bellevue, NE, and Electronic Supply of Kansas City, MO, to provide for county-wide needs for the upcoming one-year period, in the estimated aggregate amount of \$160,000.00.

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 119-95 for the furnishing of miscellaneous PC hardware and software for use county-wide; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,
