A RESOLUTION awarding a term-and-supply contract on Bid No. 196-98 for the furnishing of inmate clothing for use by the Department of Corrections to A. Lafont USA, Inc., of Crystal Springs, MS (\$69,480.00), Murray & Company of Charlotte, NC (\$18,348.00), Uniform Manufacturing, Inc., of Scottsdale, AZ (\$18,448.00), ICS of Waco, TX (\$8,896.00), Bob Barker Co. Inc. of Fuquay-Varina, NC, (\$25,633.00), and Hamilton Uniform of Crosswicks, NJ (\$3,930.00) to provide for departmental needs for the upcoming one-year period, in the estimated aggregate amount of \$144,765.00.
