### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$9,000.00 from the unappropriated surplus of the 2006 Grant Fund to cover the Sheriff's Office's Sobriety Checkpoint grant and authorizing the County Executive to execute a contract with the Missouri Department of Transportation, Highway Safety Division, in acceptance of the grant funds.

**ORDINANCE #3821**, October 2, 2006

**INTRODUCED BY** Rhonda L. Shoemaker, County Legislator

WHEREAS, the Sheriff's Office has been awarded a grant in the amount of \$9,000.00 by the Missouri Department of Transportation, Highway Safety Division, for the period October 1, 2006, through September 30, 2007; and,

WHEREAS, Jackson County is ranked first in the State of Missouri in alcohol-related vehicle crashes over the past six years and second in the state in traffic-related vehicle crashes as a whole; and,

WHEREAS, this grant will fund reimbursement of overtime used for establishing sobriety checkpoints; and,

WHEREAS, an appropriation is necessary to place the grant monies in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following
