IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a twelve-month term and supply contract for the furnishing of maintenance and miscellaneous telephone repair services for the Telrad phone system for use by the Parks and Recreation Department to Allegiant Telecom of Lenexa, KS, in the estimated amount of \$5,000.00, as a sole source purchase.

RESOLUTION # 14921, February 23, 2004

INTRODUCED BY Bob Spence, County Legislator

WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Allegiant Telecom (formerly known as Ronan Communications, Inc.) of Lenexa, KS, for the furnishing of maintenance and miscellaneous telephone repair services for the Parks and Recreation Department's Telrad phone system; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that Allegiant Telecom of Lenexa, KS, is the only known local

factory-authorized supplier of maintenance and repair services on the Telrad phone system installed
at the Parks and Recreation Department; therefore,

appropriations to the using spending agency are contained in the then current Jackson County
budget.
