WHEREAS, the Family Court Division has been awarded a grant in the amount of \$15,000.00 by the Office of State Courts Administrators in furtherance of the Juvenile Detention Alternative Initiative project for the period April 1, 2006, through September 30, 2006; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,
