AN ORDINANCE transferring \$41,945.00 within and appropriating \$125,834.00 from the unappropriated surplus of the 2001 Anti-Drug Sales Tax Fund, to cover the Multi-Jurisdictional Task Force Grant and the transfer of matching funds, and accepting said grant from the Missouri Department of Public Safety.

ORDINANCE 3187, September 17, 2001
