A RESOLUTION congratulating Joseph Bushur on his recent designation as a National Merit Scholarship finalist.

Scholarship and major in English, where he will be a part of the school's Honors and Scholars

program; and,

WHEREAS, Joseph's parents, Judge Jeffrey Bushur and Carolyn, and his brother, Michael, join in
