WHEREAS, the owners of the property have agreed to convey the necessary temporary construction easement to the County as set forth in Exhibit "A"; and,

WHEREAS, the Director of the Department of Public Works recommends acceptance of the easement; and,

WHEREAS, the cost of the easement for 44,677 square feet at \$3.00 per square foot rounds out to \$13,404.00, to be paid to J. Lamar and Deborah Smith, and Timothy L. and Carol Schuetz as a one time lump sum; now therefore,
