IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A ORDINANCE appropriating \$95,000.00 from the undesignated fund balance of the 2014 Special Road and Bridge Fund and authorizing the County Counselor to settle the employment claim of Melody L. Sloan for a total payment by the County of \$95,000.00.

ORDINANCE NO. 4672, October 6, 2014

INTRODUCED BY Scott Burnett and Dennis Waits, County Legislators

WHEREAS, former Sheriff's Office employee Melody L. Sloan has filed a charge of employment discrimination with the Missouri Commission on Human Rights in which she has alleged that certain conduct and/or conditions she experienced during her employment violated her right to be free from discrimination in the workplace; and,

WHEREAS, although the Sheriff's Office denies any discrimination, after a thorough investigation and negotiations, the County Counselor and the Sheriff's special counsel recommend a settlement in the amount of \$95,000.00 to be paid to Ms. Sloan and her attorney R. Mark Nasteff, Jr.; and,

WHEREAS, the proposed settlement will limit the County's financial obligation in this matter and is in the best interests of the health, safety, and welfare of the citizens of Jackson County; and,

WHEREAS, an appropriation is necessary to place the needed funds in the appropriate spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the undesignated fund balance of the 2014 Special Road and Bridge Fund:

BE IT FURTHER ORDAINED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is authorized to settle the claims of Melody L. Sloan, now pending before the Missouri Commission on Human Rights, for the total payment of \$95,000.00, in full, final, and complete release of all of the claims against the County and all of its employees, officers, agents, and servants; and,

BE IT FURTHER ORDAINED that the County Counselor be and hereby is authorized to execute any

and all documents necessary to effect this settlement; and,

BE IT FURTHER ORDAINED that the Director of Finance and Purchasing be and hereby is authorized to issue a check or checks in an amount totaling \$95,000.00 in full and complete settlement of all claims, payable to Melody L. Sloan and/or her attorney, R. Mark Nasteff, Jr., pursuant to the specific direction of the County Counselor.

Effective Date: This ordinance shall be effective immediately upon its signature by the County Executive.
