A RESOLUTION approving the purchase of various furniture items and refinishing services for use by the Department of Public Works from Missouri Vocational Enterprises of Jefferson City, Missouri, at a cost to the County not to exceed \$17,983.00.

INTRODUCED BY Bill Petrie, County Legislator

WHEREAS, the Director of Purchasing, pursuant to Section 1040.02 of the <u>Jackson County Code</u>, 1984, desires to purchase various furniture items and refinishing services, for use by the Department of Public Works, from the State of Missouri's Missouri Vocational Enterprises, at a cost to the County not to exceed \$17,983.00; and,

WHEREAS, Section 1064.00, <u>Jackson County Code</u>, 1984, requires that, for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the purchase from another government be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
