AN ORDINANCE appropriating \$29,000.00 from the fund balance of the 2010 Grant Fund in acceptance of a grant received from the United States Executive Office of the President's Midwest High Intensity Drug Trafficking Area Investigative Support Center for use by the Jackson County Sheriff's Office and authorizing the County Executive to execute a Memorandum of Understanding with the Kansas Bureau of Investigation.

WHEREAS, the United States Executive Office of the President's Midwest High Intensity Drug Trafficking Area (HIDTA) Investigative Support Center has allocated a total of \$29,000.00 for the period of January 1, 2010, through December 31, 2011, for an intelligence analyst to be hired by the Jackson County Sheriff's Office; and,

WHEREAS, the attached Memorandum of Understanding with the Kansas Bureau of Investigation, provides a suitable mechanism by which to implement this arrangement; and,

WHEREAS, an appropriation is necessary to place these grant funds in the appropriate spending accounts; now therefore,
