AN ORDINANCE appropriating \$25,000.00 from the fund balance of the 2010 Grant Fund in acceptance of the Jackson County Sheriff's Office "Safe Routes to School Enforcement" grant awarded by the Missouri Highway and Transportation Commission, and authorizing the County Executive to execute a Program regarding said grant.

ORDINANCE #4257, October 12, 2010

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, the Missouri Highway and Transportation Commission has awarded the Sheriff's Office a grant in the amount of \$25,000.00 to cover the "Safe Routes to School Enforcement" program for the period of August 18, 2010, through June 6, 2012; and,

WHEREAS, the Jackson County Sheriff's Department will conduct neighborhood assessments, increased moving and non-moving violation enforcement, and education programs for students, neighbors, and parents regarding traffic safety for automobiles, cyclists, and pedestrians within a two (2) mile radius of Dobbs, Ingles and Johnson Elementary Schools in Kansas City, MO; and,

WHEREAS, the Jackson County Sheriff's Department will use the grant funds for reimbursement of overtime used for "Safe Routes to School Enforcement" program; and,

WHEREAS, an appropriation is necessary to place the grant funds in the appropriate spending
