## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** transferring \$12,152.76 within and appropriating \$49,496.85 from the fund balance of the 2008 Grant Fund in acceptance of a grant received from the Missouri Department of Public Safety for the Prosecuting Attorney's Office's Victim Services Program.

WHEREAS, the Prosecuting Attorney's Office has been awarded a grant in the amount of \$37,344.09, by the Missouri Department of Public Safety for the office's Victim Services Program for the period October 1, 2008, through September 30, 2009; and,

WHEREAS, the grant will cover the salary, benefits, and training costs for a Victim Advocate; and,

WHEREAS, a match of \$12,152.76 is required for this grant; and,

WHEREAS, a transfer and appropriation are necessary in order to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,
