WHEREAS, the Director of Finance and Purchasing has determined that the higher volume discounts offered to larger entities under the state contract warrant this recommendation; and,

WHEREAS, Section 1064., <u>Jackson County Code</u>, 1984, requires that, for any such award in excess of \$25,000, the Director of Purchasing shall submit the proposed action to the County Legislature for approval; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award under the

authorized to make all payments, including final payment on the contract, to the extent sufficien
appropriations to the using spending agencies are contained in the then current Jackson Count
budget.
