WHEREAS, the County has recognized a need to address the teen pregnancy problem in the Kansas City metropolitan area; and,

WHEREAS, there is an established nexus between teen pregnancy and drug abuse; and,

WHEREAS, Truman Medical Center's StartRight Teen MOMs Program is designed to address this problem by providing mentoring for pregnant and parenting teenage girls and their families; and,

WHEREAS, this program is supported by a grant from the United States Department of Health and Human Services in the amount of \$350,000.00; and,

WHEREAS, the Prosecuting Attorney has recommended Anti-Drug Sales Tax Funds in the amount of \$72,217.00 to provide a portion of a required local match to this grant; now therefore,
