AN ORDINANCE repealing Schedules II and III to Chapter 2, <u>Jackson County Code</u>, 1984, relating to Jackson County employees not within the Merit System, and enacting, in lieu thereof, two new schedules relating to the same subject.

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, as follows:

Section A. <u>Enacting Clause</u>. Schedules II and III to Chapter 2, <u>Jackson County</u>, 1984, are hereby repealed, and two new schedules enacted in lieu thereof, to be known as Schedules II and III, to read as follows:
