AN ORDINANCE appropriating \$36,342.00 from the fund balance of the 2008 Grant Fund in acceptance of the Family Court Division's Community Restitution Program Grant received from the Missouri Department of Social Services, Division of Youth Services.

WHEREAS, the Family Court Division has been awarded a grant in the amount of \$36,342.00 by the Missouri Department of Social Services, Division of Youth Services, for the period of July 1, 2008, through June 30, 2009; and,

WHEREAS, the grant funds will be used to fund the Community Restitution Program, which provides a means for juvenile offenders to perform community service as restitution, and requires the offender to attend a victim impact panel to learn how crime affects individuals and their families; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made from the fund balance of the 2008 Grant Fund:
